## **How much can you earn as a Navy Certified FCC Provider?**

### **Subsidy Cap (based on region)**

Full day.....6 weeks to 23 months of age.....\$1300 per month

Full day.....2—12 years.....\$1000 per month

School year care.....\$680 per month

Subsidized hourly care.....\$15 per hour

*Providers may set their own private-pay rates.*

### **Incentives available:**

Initial Certification.....\$250/quarter up to \$1000 first year only

Referral Incentive.....\$500 per referral

Transfer Incentive.....\$500 per transfer

Retention Incentive.....\$1000 annually upon successful recertification

# Types of Care

**Full-time care** (offers a minimum of 50 hours of care per week)

**Part-time care** (including before/after school care)

Hourly/Drop-in care

**Extended care** (evenings , weekends, federal holidays - work related)

**24/7 care** (non-traditional hours on a regular basis, usually for shift workers)

**UTA care** (for Guard/Reserve Drill weekends)

**Childcare for PCS** (Air Force specific; apply online at

<https://portal.afas.org>

within 60 days of inbound/outbound date)

Other Air Force services: **Military Spouse Appointment Care, Deployment Child Care, Emergency Medical Care, Wounded Warrior Care, Child Care Support for Fallen Warriors**

**Ombudsman and Key Support Liaisons (KSL):** care provided

while performing official duties

## Requirements to become a Navy certified FCC Provider:

Be 18 years or older

Hold a high school diploma or GED

Be a US citizen or have a Social Security Number

All household members must undergo a background check and have documentation of current immunizations

Home environment must pass a Fire/Safety and Health/Sanitation Inspection

Purchase liability insurance

## Unauthorized Childcare in Family Housing

The 36 MSG/CD has issued a policy in support of AFI 34-144 Child and Youth Programs that prohibits military housing residents from conducting childcare in their military housing without first becoming certified. Any resident providing more than 10 hours of childcare per week in their base housing must be certified as a Navy Family Child Care provider. Failure to comply with this policy could result in loss of housing privileges. For more information, please request a copy of the policy letter from the housing office or the FCC office.
